COMMITTEE REPORTS

Public Liaison Report: Leon Berggren absent – Ellen –

- BLM Meeting – Tony – Community Economic Profile – concerned about the economy. Lots of theories, older people leaving during the winter. Young people leaving. New 20 year plan. BLM will be commercializing as much of their property as they possibly can. They want public input on the direction they should go. They are selling off massive amounts of property to the highest bidder. Property up for sale is not really publicized, done as quietly as they possibly can, public notice in the newspaper. You can get on a mailing list through the district office. If you want to give input contact the district office. Their web site will be published in newsletter.

State Directors Report: Joanna Stroeder, Robbin Schindele, Phil Ryan –

- Robbin - State Board Meeting, Salmon - **Calendar sales** going well, only 400 left to sell. At this point the profit is \$12,000.00, if all calendars sold profit would be \$20,000.00. It was suggested that next year the location of the photo and the photographer be listed on the calendar. Phil needs all of the money collected for the calendars by January 15th. Any extra calendars will go out to chapters that want them and any extra that are not sold could be brought to the Outdoor Show. **Update on the Grand Canyon trails** - Kaibab Trail will be closed for reconstruction for two years and then Bright Angel Trail will be closed while it is reconstructed. **The Pistol Creek bridge** situation has been resolved, will be reconstructed, just not sure when. **The High Desert Club** designed a camping loop and put in horse facilities -Porcupine Springs. When it was completed the Forest Service took it over and made it a reservable loop, which High Desert had no idea was going to happen. **State Insurance** will not cover an overnight Kids Kamp event held by Twin Rivers. It was require an additional policy for \$1600. Will look into different insurance. **NAIS** – Horse Council in favor of program but not for equines, just food animals. Roll call by chapter determined that all opposed. **2009 Show** - our job will be to assist with the Bucket Raffle. **Trail classifications** have now gone back to what they were before. **Education Manual** - Marybeth updated education manual and provided a copy for each chapter, it is also on the BCHI web site.
- Phil – Chapter dues by Jan 31, 2009. **Life Flight** – used twice last year – no out of pocket expense to person. Should be used for members only. **Idaho Horse Board** has lots of money for grants. **Pistol Creek cabin** - FS wants us, TV & Boise chapters to maintain it. Robbin has produced a **poster for the Mountain Bikers clubs** of what a horse sees on the trail. Our **Public Liaison representative** needs to go Horse Council and Horse Board meetings. **State Officer positions** are open, if anyone wants to volunteer. **State web site** is up and running. **MaryBeth** is being put in for the Double Diamond service award for producing the education manual. **Minutes from the State Directors meeting on SBBCH web site.**

Education & Foundation Reports: Margaret Berggren absent –

- MaryBeth - **Idaho Horse Council** – BCHI used to have majority on board, now we have no one on the board, this is a concern. **Convention** will be in Twin Nov 2009. BCHI is working on a **video** for public presentation. **BCHA web site** - see the letter regarding **trail classification**. - Horse Affairs – Tony- at Idaho Expo - second weekend of February, will need people to volunteer. TV wants to share a booth.

- Incorporation status – Ellen – thanks to Bill for getting this going. We are now registered with the state and incorporated. We will now be putting money in the bank for a CD. Charles has checked on some CD's but hasn't found what we want at this point.
- Calendar status – Phil - Phil needs all the money to be sent in by Jan 15th. Jan 31st is the first prize drawing. All elected officials in Idaho will receive a complimentary calendar.
