

## **Traveling with your horse?**

### *General Equine Health Requirements for Interstate Movement*

#### **General Information:**

- All states require a Certificate of Veterinary Inspection (CVI) for equine prior to entry. The timeline for this to be completed prior to entry may vary by state, but generally it is within thirty (30) days prior to entry. Some states, including Idaho, will except equine from specific states with a six (6) month extended validity health certificate, commonly known as an equine passport;
- Most states require a negative Equine Infectious Anemia (EIA) test, commonly known as a "Coggins" test within six (6) or twelve (12) months before entry;
- Many states, including Idaho, have Equine Viral Arteritis (EVA) restrictions in place for the movement of intact male equine (Stallions) and require testing and/or vaccination prior to entry;
- Some states require an entry permit number to be issued prior to entry.

#### **Important thing to remember:**

- Each states equine import requirements will vary and may change at any time due to certain disease outbreaks or animal health concerns.
- Prior to traveling, contact your private veterinarian to obtain a Certificate of Veterinary Inspection (CVI) and let your veterinarian know your plans. Your veterinarian will contact the state official for the state which you plan to travel to and determine the import requirements for that state.
- Some required tests, such as a Coggins, may take several days to complete and it may be more than a week before your veterinarian receives the results. Plan ahead in order to ensure these factors do not interrupt your travel plans.

There are several internet websites available that list the equine import requirements for each state. When using these sites as a reference to establish movement requirements, remember that the resource may be out of date or inaccurate. Below I have listed a couple of sites that may be helpful, but remember that the safest way to insure that you are meeting each states individual requirements is to contact the receiving state and inquire.
