- Headquarters Report

- Governance Policy changes were accepted
  - Clarified EC membership for Past Chair, Nondirector members and Director members

- The Resolution introduced by WA to start a Constitutional change to reduce NBM/State to one director was defeated

# Tuesday April 9

- Public Lands Day
  - A full day dedicated to Building Partnerships and Growing Opportunities. We heard from Region 8 USFS about the progress and impact of the Forest Stewardship Act and about the criticality of public participation in Forest Planning
  - We witnessed a panel discussion regarding a case study in collaboration involving bikers, foresters, whitewater conservationists, Wilderness Society and BCHNC
  - Heard a dynamic and uplifting presentation regarding BCH support of the Great Smokey Mountains National Park and the Appalachian Trail
  - Capped by Keynote speaker, Executive Director of American Trails – truly inspiring speaker

# Tuesday April 9 (cont)

- Key Takeaways
  - Forest Stewardship Act is starting to take hold
    - Participation is key
  - Upfront, early and often. WE must participate in forest planning if we expect to be recognized as a player – be proactive, not reactive
  - Coalitions of user groups are key to successful plan creation
    - WE have a lot more in common than not
  - Many public land managers respect what horsemen can bring to the table and trail
    - Many do not know anything about horses
    - Rules and regs must be followed to the T if we want to benefit from partnerships and liability
    - Use National Park Foundation documents to get nose in door
  - RECREATION is our USER group
  - Collaboration and representation is as important as sawyering.
    - BCHI shared as a success story the sawyer training that is now ongoing in BOTH regions!

- Passed Resolution introduced by WA and OR to communicate to the USFS Chief that BCHA supports mandatory MRA process for trails affected by natural disaster or if they have not been maintained in over two years making them inaccessible to pack and saddle stock.
- Broke into Committees for the day

  1. Education Committee, Marybeth and Aline
  2. Regarding the Public Lands Multi use sticker idea from BCHA, BCHA Regional Manager asked that a BCHA public lands representative attend one of the BCHA public land monthly phone conference and bring up the idea there.

- Accepted BCHA Wyoming's proposal to host 2021 NBM in Cheyenne, WY
