 during the period when the National Board is not in session and to provide continuity to the collective memory of BCHA. This
 Executive Committee will consist of the Chairman, Vice Chair, Treasurer and four National Directors to serve a one year term.

Whereas, BCHA has great concerns as to the impact the "specialized" recreation fee will have on volunteer efforts in the Shawnee National Forest by equestrians,

THEREFORE, BE IT RESOLVED that Back Country Horsemen of America opposes the proposed special permit fee to cover the cost for providing specialized services on the Shawnee National Forest.
