Director of Development – Kandee Haertel

Kandee has prospects on line awaiting our 501c3 approval. Larry will go in his local newsletter promoting the letter;

Front country and back country – we represent recreational pack and saddle stock on public lands. This is an issue in the mid-west and east; people in east are uncomfortable with back country horsemen representing them. Seeing some push from public land managers to get a new organization for trails (front country versus back country). President is trying to shove through an executive order that would change how the NPS manages their trails (NPS trails and Wilderness areas within the parks); make changes without public input; American Hiking society is very opposed and asked for our help in opposing this. Big issue is transparency and public process. If this comes in, it is done by the park superintendent without any public process at all. Talks are on-going with AHS on public process.
