Kandee is trying to get in touch with them; Dennis talked to them at AHC in DC. A lot of the projects are done by BCHA so need to get the information out. ELCR is bending over backwards for us; wants Terry to come to their board meeting.

Phil – need to figure out the answers: how to keep their identities and 501c3 status.

- 7) National Park Service, National Forest, American Hiking Society, Wilderness Society, Federal Transportation Highway Department. (Affiliates/Sponsors/Advocacy) American Trails.org, MOU's and can we put their logo's on our website as supporters?
