Purpose: The purpose of this initial meeting is to share information concerning our Wilderness trail system and its evolution over the past 3 to 4 decades. Most of the groups attending this meeting have experienced a decline in overall Wilderness trail maintenance, the quality of maintenance which does occur and a shrinking of accessible trails for pack and riding stock as well as for hikers. Essentially we are meeting to identify these shared problems and help find solutions. Overall this first meeting is to explore the idea of forming a coalition or council with which to raise an awareness of these issues as well as help guide direction for solutions. This meeting is not intended to be a platform to bash the management agency or discuss Wilderness constraints on tools. It is intended to share issues, raise awareness and find constructive solutions. The design for this meeting is to introduce the various organizations and agency folks who have an interest in Wilderness trail maintenance in Idaho and the Western states. We will try to split the day with brief morning presentations by the agency and groups to identify problems surrounding Wilderness trail maintenance then spend the afternoon in a round-table discussion generating action ideas to approach those problems.

This is more of an exploratory meeting than a definitive one. Along that line, if there are items that aren't listed on this agenda, please know that, given time, we will attempt to cover them.
