- BRAND INSPECTION REQUIRED AT: CHANGE OF OWNERSHIP / LEAVING THE STATE / SLAUGHTER / WHETHER OR NOT THE ANIMAL IS BRANDED
- 2. TYPES OF BRAND INSPECTIONS FOR EQUINE / LIFETIME SEASONAL FIELD INSPECTION
- 3. TRAVELING "INTRA-STATE" IDAHO YOU NEED IN YOUR POSSESSION, SOME FORM OR A WAY TO ESTABLISH "PROOF OF OWNERSHIP"
 - a. Idaho Brand Inspection Another states Brand Inspection
 - b. Brand Card / Livestock branded with your iron
 - c. Bill of sale??? (Should be a brand inspection)
 - d. Purebred Registration papers
 - e. Health papers
 - f. Trip Permit / Filled out & dated
- 4. TRAVELING "INTERSTATE" IDAHO / BRAND INSPECTION / HEALTH PAPERS-COGGINS
- WHEN TO STOP @ PORTS OF ENTRY ROVING PORTS, ETC
 - a. All livestock entering the state of Idaho must stop
 - b. If you are hauling livestock and your GVW is over 10,000 pounds you must stop
 - c. The fine for blowing through a POE can be approx \$200.00...
- 6. Livestock theft around the state in the last couple of years, more attention is being placed on livestock movement by all law enforcement agencies statewide
