Education Report - Nancy Harper-Schindele - Nothing to report

Foundation Reports - Bill Conger and Bill Holt

Anyone wishing to donate money to a specific BCH project or club can receive a tax credit for their donation if the money is processed through the foundation. The Foundation charges a 5% paper handling fee and returns the balance of the donation for project or club use.

The Foundation can also give an "in kind" receipt for mileage that has been logged and driven by a member for BCH activities. For members of a club, a tax donation application for receipt must be signed by the SBBCH Foundation Director. The application is then mailed to the Foundation. The Dollar Equivalent allowed for the miles driven will be figured and a receipt sent to the individual for tax purposes. There will be no processing fee. The allowed amount for non profit groups is much lower that for business expenses but if you itemize your tax return it gives you some credit.

Public Liaison Report - Robbin Schindele, Tony Buthman, Bill & Chris Holt

Rob has meetings scheduled in December with both the BLM and Emmett Forest Service.

State Directors Report - Robbin & MB

Not all BCH groups have the wonderful working relationship we have with our local Forest Service.

The Forest Service is working on new maps with the new trail designations. Most of the currently available "trail maps and classifications" are 20 years old. Several years ago BCHA brought legal suit against the Forest Service over the FS trail classification and reclassification processes. The public had not been given the opportunity for input prior to the reclassifications of many trails in our National Forests. BCHA is now asking each chapter to verify that public input was requested prior to reclassification of trails. Robbin is heading up a committee to check reclassifications in the Boise National Forest. Anyone wishing to help Robbin please contact him. He will be checking on trails and verifying their current classification and how it was assigned. The information gathered will be presented at the March BOD meeting.

BCHI has \$1,700 available to put toward education on a state level. The 2011 Wilderness Pack Clinic falls into the education category at a state level, so we should have access to funds to help with clinic costs.

Work Projects and Rides Report - Rob Adams and Tony Buthman

Rob reminded everyone about the rapidly approaching August Pack Clinic. The web page summary has been updated. Site visitors can see what participants can expect from the clinic, a list of the planned evening entertainment, info about the pack in, clinic instructor bio's, etc. The web site is receiving numerous hits from both in state and out of state. Rob has a meeting scheduled December 8th with TJ with the BLM about projects both inside and outside the Owyhee wilderness areas. TVBCH and BBCH club have been notified of the meeting if they wish to attend.

December 15th at 8:30 he has a meeting schedule at the Emmett Ranger Station. One of the items he hopes to discuss is training on weed spraying in the National Forest.

American Quarter Horse Association would like to co-sponsor a Hard Trigger trail ride with us some time in May.
