12 of 15 chapters were present; Cache Peak, North Idaho & Sawtooth absent Minutes MSP

9:00 - Treasurer's Report – Kay Ryan, State Treasurer

9:30 - State Insurance Report – State Chairman

Chapters need to get their public events in by December 1, 2012. We have always thought SBBCH had two events insured regardless of the event's length, this is not true. We have had two insured DAYS. 10:30 - Job Description for State Education Chair position - Steve Didier

This position is not filled. It was stated by previous chairs that the job is primarily as a coordinator for chapter activity and an administrator/archiver of education materials on the BCHI website. If the chair wants to make the job more robust they have that latitude to do so. Chapters were encouraged to solicit a volunteer to fill the position. 11:00 - Follow-up on Frank Church proposal & Lochsa Packer Position proposal

Phil presented his activity supporting the Frank Church proposal. He has received support of the proposal from various ID equine and outdoors group as well as that of US reps. Simpson, Rich and Crapo. The forest service has not responded. His efforts were praised by the board. Chapters were encouraged to reach out to their respective state and federal reps on the issue.

The Lochsa Packer Station was staffed and maintained this summer by volunteers from the North Central Idaho chapter. The stock is still there and maintained by the NFS. The Packer Position has not been filled and the feelings are it never will be.

There was discussion about a state Facebook page. Does any chapter have someone willing to volunteer to manage the page? Rod AGAIN asked chapters to please place all their events on the state calendar. IF we don't it lookslike we don't do much and reflects poorly on the org. He asked me if I could find a way to make the "Horse Sense" video into a single download rather than the sections it in now. He wants to a page of photos and links to chapter photos. Rod is going to pursue the potential of selling calendars on the site with our web master.

Rod and I talked about recent executive committee minutes and associated activities at the national level. Anyone who wants more details or copies of these reports can contact me for copies. Val Johsnson, Salmon River, had a fair amount to say about some of the events at the BCHA BOD meeting. He, and his chapter, STRONGLY oppose the BCHA BOD's resolution to release the BCHA membership to companies willing to donate \$10K to BCHA as a sponsor (now called "Partner".) Salmon River also opposes the addition of the chapter email addresses to BCHA for the monthly email BCHA newsletter. They also STRONGLY oppose the proposed BCHA dues increase without an explanation of how the increase will be used. The process for this increase was also discussed. It was stated that <sup>3</sup>/<sub>4</sub> of the states must ratify the increase at the 2013 BCHA BOD meeting for it to go into effect. All chapters need to discuss the increase and the membership must vote on the issue at the 2013 state convention.

## JOB DESCRIPTION

#### BCHI EDUCATION CHAIR

The Education Chair, or if the BOD (Board of Directors) so chooses, Co-Chairs, serve at the pleasure of the BOD and Chairman. The choice of an Education Chairman by the BOD Chair must be ratified by a simple majority of the BOD since this is a permanent position.

The Education Chair (hereafter referred as EC) is primarily responsible for the **coordination** of the state-wide BCH education effort, both public and in-house. The EC is responsible for ensuring that the education materials available through bchi.org are current and relevant.

The EC is responsible for making every effort to ensure that chapter education chairs are familiar with and current with all relevant educational material maintained and offered by BCHA and its' member states. The EC will accomplish this by establishing & maintaining communcations with all chapter EC and by presenting, or having someone else present, one educational item (either new, used by another state or presently in the BCHI Education Manual) to members at each BOD meeting & at the Annual Meeting.

The EC is responsible for preparing recurring reports to the Chairman and BOD at the annual membership BOD/Annual meeting. The EC is also responsible for preparing interim reports to the Chairman and BOD at each BOD meeting throughout the year.

The EC will submit a budget proposal for projected needs and projects for the upcoming fiscal year to the Chairman at least 30 days prior to the annual meeting.
