Sponsorships work – trying to get in line with companies for next budget year.

Tractor Supply (Alan) – local store is interested; very aggressive marketers in California area.

Advisor for Wilderness & Recreation, Randy Rasmussen -

Outreach & partnerships – Jim Schembs BCH member developed Project 30; had meeting with Region 6 FS on Project 30 – will consider chainsaws in wilderness only on a site-specific, case by case basis (in other words, they did not appear open to Jim's proposal for a forest-wide exception for chainsaw use in wilderness if trails not cleared with 30 days after being snow-free).; let Randy know if trails are not being cleared, keep record of trail maintenance not being done.

BLM Environmental Assessments – now in Oregon but will have national aspects or at least regional; taking playbook from IMBA; converted historic horse trails into bike trails; BLM is applying nationally; very stringent criteria; has decided horses can't be there on the 25 miles of trails; sent a letter asking for extension of comment period through Oct 3rd or 4th. The BLM agreed to extend the public comment period to October 4th. Don't want these standards applied nationally. Lots of comments from Disciples of Dirt wanting to ban horses from this trail system. Local BCH are writing letters. (Rick McLean & Yvette Rollins talked with IMBA at Great Outdoors in WDC.) Randy will work up a short alert of this situation.

American Trails Symposium – will have our exhibitor table; Yvette put together a proposal; leveraging land managing and trails being maintained; April 14-17 in Scottsdale; our National Board Meeting at end of month; 75 minute presentation (2 or 3 sessions). Alan willing to talk with Pam Gluck; she wants us to participate; Public Land Service Corps willing to have contingent or one person there to support mission.
