 - ✓ Rob Adams reported on the Volunteer Hours & the full report can be found on the website. The value of Squaw Butte's efforts came to \$132,000 for 2018.
- > State Directors/National Directors: Phil Ryan stated that he has been on a phone conference with BCHO (Oregon) and BCHW (Washington) members who are going to present a proposal at the national board meeting concerning the use of (MRA) minimum requirement analysis by the Forest Service in wildernesses to clear trails using chain saws due to the back log of uncleared trails.
