Idaho horse council Report: Dan Waugh – Chair Trail Urban Spaces, Director with Idaho Horse Council

- Goal have Horse Council be a resource for one voice for equestrians across the state. Trail Liaison in Ketchum & a Lady in Moscow
- Need unified voice across the state 3% of state GDP is recreation dollars revenue per BSU survey Equestrian is third at \$125 million in 2019.
- Horse census on ID Horse council webpage not a great census Boise State didn't process it very well.
- Health Issues Strangles and other issues –need contacts across the state.–
- Expand Petit Lake Trail head
- Outfitter Association does a lot of trail maintenance
- Legislative network need to utilize.
- Horse Expo is April 8-10, 2022 -there will be a pack clinic horse TV air time last year hope to get more this year.

National Directors Report: by Aline Brinkman

National News Letter, quarterly, everyone getting? If not let Aline know.

- Volunteer Hours Form: Use old sheet with 15 categories vs. new form now down to 6 categories...more to come on this issue.
- Grants out there on BCHA website \$50k available minimum of \$2k to \$15k cash or in-kind match of at least 20%.
- Horse camps designated as such but others using | Take pictures, notes, License Plate numbers send to parks and rec or FS district office or BLM district. There is a form on the BCHA website and a link on the BCHI home page to help track and report this issue.
- E-bike policy white letter coming Aline to pass it along once she gets it.
 - USFS is resisting classifying E-bikes same as pedal bikes –
 - o BLM lets them go same as pedal bikes.
 - National Parks Service lets them go same as pedal bikes.
 - State of Idaho allowed them, on State Lands, same as pedal bike back in 2020.
- E-Bikes State of WA, pending public comment, currently temporary option if have Americans Disability Act [ADA] sticker allow them to go where pedal bikes go. Public input deadline is 4/22/22. Twin Rivers sending a letter on this.
- 1.17.22 USFS Prescott CLASS 1 E-Bikes not heard the outcome yet.
- CA took non-motorized and allowed motorized then had to rescind but are now trying to get it back in legally with public comment process.
- BCHA NL sent electronically what is status of this. Addresses of people for paper newsletter let Aline know for updating with BCHA. BCHI has members that don't have computers so no way to get them online.

Public Lands Reports:

- North: Gary Kalmbach keep equestrian designated camping and parking spots open to equestrian
 use. On website incident report send a copy to all chapters conference call every 3rd Thursday of
 the month with NW public lands discussion with all the states CA AK OR WA ID—
- South: No Report
- East: Tim palmer Caribou-Targhee NF Centennials
 - Gold exploration X next 3 years. More congested and noisy
 - Trail head improvements all on hold, because of gold exploration
 - o Reroute Lake Creek, Fleming Creek-Big Holes out of Palisades
 - West Fork Mink Creek 2 bridges and 2 culverts upgrade to larger
 - Salmon-Challis Bellas Lake Broadview connector trail start of summer when snow clears Copper Basin area
 - o BLM District Manager can allow e-bikes [per BLM website] with written letter for that region in the future, BLM not currently doing this, just need to stay aware and monitor for changes.

- Steve Didier referenced the fact that the change in the volunteer hours form was not sent to the state
 organizations or chapters for review speaks to a disconnect in the National Board and the rest of the
 organization, possibly due to the management team that has been hired.
- Steve Didier asked about why legal fund not same amount as Legacy fund? Sees e-bikes as next issue that will end up in the legal process.
- When members donate to BCHA they can designate where the funds are designated to go example Legacy fund trails forever goes to the grants that BCHA.


Location for Sept 2022 Directors Meeting: hosted by Priest River BCH- on 9/10/2022 - location TBD.

Letter to BCHA - Volunteer hours form

Rod Parks- Read updated letter and it was unanimously approved, Chris Reed signed it and gave it to Mark Himmel.

LETTER:

ATTN: BCHA National Directors and Executive Committee Members,

Volunteer Hours Form was developed using the Mission and Purposes of BCHA as the blueprint for its design. As a result of that design and the data that was compiled from it BCHA has been the recipient of numerous awards for its volunteerism from the USFS. Most notably USFS Chief Jack Ward Thomas awarded BCHA an inscribed slate shingle from the Aldo Leopold house in Washington DC for outstanding volunteerism in excess of any other volunteer organization.

BCH of Idaho members share a great concern regarding the new volunteer hour reporting form provided by BCHA.

In an effort to provide clarity and transparency regarding our volunteer hours, we would like to bring to your attention a few concerns with the calculation of true volunteer hours of value:

- 1. Elimination of reporting "Wilderness Trail" miles and "Other Trail" miles
 - Specifically, no record of mileage performed by volunteers.
- 2. Elimination of Community Service hours and reporting these hours under one category as "Other Volunteer Hours"
 - BCH Mission Statement specifically indicates Education and Outreach will be a high priority within the organization. Currently this new form has no record of our educational hours or attendance at public meetings nor administrative duties.
- 3. Elimination of actual number of stock utilized on projects.
 - For example, currently if you have 8 stock utilized on a 3-day project, it would be identified as only 3 stock days. It does not take into consideration the actual number of stock

needed to complete the project. The old Volunteer Hours Form would have recorded 24 stock days with the same example.

As a result, the BCHI Annual Convention assembled delegates demand that BCHA return to the Volunteer Hours Form used prior to this condensed form from BCHA in 2021.

Sawyer Training: Region 1 Todd Brown, North Central & Region 4 Rob Adams, Squaw Butte

 Forest Service getting out of business of Saw Training. New program, Volunteer Saw Instructor new course called "Developing a Thinking Sawyer" emphasis on risk management, human factors, and sawyer safety.

FS saw training and trails

- Brian Burbidge Region 4 Saw Program Manager- resources for fire support
- Larry Velarde Region 4 Trails/Dispersed Recreation & Travel Mgmt. Program Manager
 - Saw program –close to filling position permanently with someone who won't be pulled away during fire season.
 - Power point presentation
 - o Todd Brown BCHI Region 1 N of Salmon River
 - o Rob Adams and Mark Ottman Region 4 S of Salmon River
 - Quarterly calls with partners 35 organization to keep all partners on same training page with updates as they come out.
 - Partner workshop "train the trainers" all operating under the same program recertify all the extensions and recertify trainers and continue it through the fire season.
 - Nationally new saw policy that should be signed soon.
 - Changes ability for designated B sawyers to instruct and evaluate A sawyers that will allow for more instructors.
 - Way in which partner programs get recognized to sign their own cards.
 Old system very convoluted new process more streamlined
 - PowerPoint –Volunteer agreement trained, evaluated and certified in accordance with saw policy #2358 to get cards.
 - 30 different programs currently working with which include BCH of Wyoming, Idaho, and Utah.
 - Added PPE requirements in the chainsaw portion.
 - National database still being developed in the works for the past 6 years

- Course will be the same across the board no matter what region you are
- Course has been in development for the past 4 years. You will be able to select the modules for what certification you are working on.
- Still in the works not yet finalized but getting closer maybe by fall will have new modules with new videos.
- Big picture-consistent message across the board all have same understanding and safety training and processes.
- Why to provide a sustainable system of trails,
- Shared trail stewardship act signed into law in2016.
 - Need to Increase volunteers by 100%
- Central Idaho Wilderness complex –area of enhanced trail maintenance
 - 2018 issue been aware of this and trying to send more funds that way
 - If have positions filled will be able to put more toward trails
 - Currently seasonal hiring process is broken
 - They lose many of the positions that are filled in Sept for start in May and then the hires find another position leaving the seasonal positions unfilled.
