## Idaho Non-Motorized Trails Permit Poll

## **Background:**

Idaho has had exponential growth in recreation over the last several years due to the population increase, as well as out of state visitors. In the past few years Idaho has seen almost 100% growth in terms of people recreating here in Idaho. This increase both from residents and non-residents vacationing in Idaho has taken its toll on our already suffering non-motorized trail-systems across Idaho. These trails were already in need of repair and it's only getting worse with an increase in every user group utilizing our trail systems.

Idaho already has recreation demographics paying to use our state. The Motorized community came together in the late 1970's and requested legislative action to require an annual sticker to use dirt bike and later ATV/UTVs on motorized designated multiuse trails. This program has generated multi-millions in revenue which has not only maintained but improved Idaho's motorized trails. Boaters also require a boating sticker, as do RVs and campers. These funds go back into the lands we love. Currently multiple user groups are looking at determining if a mandatory non-motorized trail access permit/sticker would be supported by the majority, to be able to have a reoccurring and annual revenue source to address the deteriorating condition of our non-motorized trails.

This would not affect winter permit programs already in use, instead this would be a spring-through-fall type permit. If you participate in the park and ski program, this would not affect that since those funds are utilized to keep parking areas plowed for use. Instead, this would generate funds that federal agencies or service organizations could apply to projects that have gone unfunded. It's unknown exactly how much this could generate, however it likely would exceed \$1M annually, which when looked at in the long term could positively affect our trails in a huge way. These funds would not just go the state "general fund". We believe Idaho Parks and Rec has done a great job with the Boat, RV, Yurt, Park and Ski, and Motorized programs and would excel at managing the non-motorized funds as well.

Many states surrounding Idaho already have similar programs in existence. Idaho has even tried an Equestrian trailer fee and Mountain Bike registration but both failed, due to the pressure being placed on one user group instead of all users. Currently our non-motorized trails have no annual revenue. Most of the trail work is done with grant money and by volunteer service organizations. If we had a recurring revenue stream that was available to these organizations, as well as state and federal funded trail crews, what could our trails become?

Many will argue we should not have to pay to use our public lands, and while many of us would agree with that belief, we must still understand what it takes to keep our trailheads and trails maintained and open. Hence many are trying to find a way to generate revenue to support our trail systems.
