 - Park N' Ski
 - Mountain Bike Vanity License Plate
 - Equestrian Trailer Plate (tried twice in the late 90's)
 - Mountain Bike Registration (Tried twice in the 90's)
 - Yurts/Huts
 - RTP Grants
 - General Fund
 - Selway Bitterroot Frank Church Trail Foundation
 - Idaho Trail Association
- Washington
 - Annual Northwest Forest Pass for all federal sites
 - USFS Forest Day Pass
 - Discover Pass for State Parks and Fish/Wildlife state trailheads (\$10 per vehicle)
 - Sn-Park Pass
 - USFS and National Park/Monument Wilderness Permits
 - State Park Car Tab renewal donation
 - State Fish and Wildlife Vehicle Use Permit called VAP (Now Free to Fisherman and Hunters. Allows access to WDFW Lands
 - State Gas tax to Non-Motorized Trails
- Oregon
 - Annual Northwest Forest Pass for all federal sites
 - USFS Forest Day Pass

 - RTP/LWCF but has a non-motorized trail coordinator position like Idaho. Mostly develops state park trails

- Utah Outdoor Recreation Grant. Comes from a Utah motel room tax that is distributed through Utah Tourism Dept.

 - SnowPark
- Colorado
 - Great Outdoors Colorado Program. In 1992 a citizen initiative redirected lottery funds to state parks, wildlife, conservation, trails, river and open space capital construction projects
 - Colorado Trail Foundation. A private foundation dedicated to constructing and maintaining the 700 mile long Colorado Trail.
 - Colorado Outdoor Recreation Search and Rescue Card (CORSAR) It is a donation to SARS. It is not an insurance card. SARS will not bill you.
- Minnesota
 - Regional Trail Grant Program. Funding is from: "In Lieu Of" lottery proceeds.
- Arkansas
 - Trail for Life Grant Program through Arkansas Dept. of Health and Human Services. Monies come from Tobacco Settlement Proceeds Act.
 - A 2008 State Trails Fund bill to create a 2 million dollar general funded program. I could not find if it passed.
- Arizona
 - Arizona Trail Fund that is used to fund work on the Arizona State Trail. Funded through donations and other sources like legislative appropriations
